


Upon deliberation on the issues, the recommendations of the committee are as following:


1. The nominations in respect of the Office Bearers (President, Vice President, Secretary and Joint Secretary) in all colleges shall be the same as has been resolved by the High Power Committee in its meeting held on 2/9/2014, and shall be adhered to in letter and spirit.
2. As regards to the inclusions of certain courses / subjects at Sr. NO. 9, the committee clarifies that it shall include B.Sc (Bio - Tech), BJMC and all such courses that are run by the college.
3. The committee clarifies that under the heading: **Important Note** at page 6 under (i) it may also be read that the merit and eligibility of the candidate to be nominated from PG classes in colleges shall be the same as for PG students nomination in the university.
4. On a written clarification sought by the Chairman Department of Computer Science, regarding the inclusion of M.Tech. nomination, the committee clarifies that M.Tech shall be included in addition to M.Phil and L.L.M. under 2(C)(d) at page 3.
5. The committee also clarifies that the constituted CSCA shall remain functional till 30th June as under Sr. NO. 6.

The meeting ended with a vote of thanks to the chair.


